District 157-C August 29, 2016 Special Board of Education Meeting Recap

The Frankfort School District 157-C Special Board of Education meeting of August 29, 2016 was called to order by Board President Gina Briese at 8:02 p.m. The roll call was taken and a quorum was present. The Board recited the Pledge of Allegiance. No one signed up to speak during the Public Forum portion of the meeting.

The Board discussed the Administration's recommendation for the remaining staff needed for the new school year.

The Board took action to approve the employment of Christopher Boyle as a One-Year .67 Full-Time equivalent 7th Grade Teacher (BA +0) at Hickory Creek Middle School at an annual salary of \$30,703.42 for the 2016-2017 school year, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Maggie Sayles as a 7th Grade .67 Long-Term Substitute Teacher at Hickory Creek Middle School with a tentative start date of August 26, 2016 and will continue as determined by the Board or until the assignment ends, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Kenneth Meracle as a 7th Grade Long-Term Substitute Teacher at Hickory Creek Middle School with a start date of August 25, 2016 and will continue tentatively through December 2, 2016, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Julie Tencza as a 5th Grade Long-Term Substitute Teacher at Chelsea Intermediate School with a start date of August 22, 2016 and will continue until the 2016-2017 assignment ends, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Judith Rice as a Long-Term Substitute Speech and Language Pathologist at Grand Prairie Elementary School with a tentative start date of August 26, 2016 and will continue tentatively through November 7, 2016, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Pam Melnyk as a Part-Time Lunchroom Aide at Grand Prairie Elementary School at an hourly rate of \$11.50 for the 2016-2017 school year, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Julie Saldok as a Full-Time Instructional Aide at Grand Prairie Elementary School at an hourly rate of \$13.45 for the 2016-2017 school year, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Laura Pasciak as a Full-Time Instructional Aide at Grand Prairie Elementary School at an hourly rate of \$12.50 for the 2016-2017 school year, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Nicole Carella as a Paraprofessional at Grand Prairie Elementary School at an hourly rate of \$12.05 for the 2016-2017 school year, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board took action to approve the employment of Brittany Host as a Full-Time Paraprofessional at Grand Prairie Elementary School at an hourly rate of \$12.00 for the 2016-2017 school year, contingent upon the receipt and evaluation of employment documentation required by District 157-C and the Illinois State Board of Education.

The Board went into Closed Session at 8:07 p.m. to discuss appointment, employment, compensation, discipline, performance and/or dismissal of specific employees; student discipline; student residency; student issue; reclassification of employees; and pending litigation.

The Board returned to Open Session at 9:38 p.m.
